WELCOME & ADMINISTRATIVE

FC MOTION: *Brundage moved and Bradley seconded to approve the May 30, 2023 FC Virtual Meeting minutes. Minutes approved.*

FC BUDGET ACTION ITEMS

Smith summarized the 2023 PRRIP FC Procurement Table, the action item for today, and upcoming items for FC review. Rabbe asked about additional complexes being included under the in-channel diking work that are listed in the RFQ but are not noted in the Procurement Table. Smith said Tunnell's RFQ and plan of work is controlling and he can address this later in the FC meeting today.

FY23 PROCUREMENT UPDATE

Farnsworth summarized:

- **North Platte Chokepoint Engineering Services RFP** – Anderson Consulting Engineers now under contract evaluating alternatives to increase capacity at the Choke Point. Anderson is meeting with the PRRIP Chokepoint Workgroup next week to discuss an initial screening analysis.
- **Recapture Reconnaissance Study RFP** – The Selection Panel selected Leonard Rice Engineers to conduct this work. Their budget came in high so the EDO asked them to take a hard look at their proposed budget and see if they come back with any savings. We will work to get it as tight as we can and then will go back to ask the GC for a line item budget increase if necessary. Bradley asked when the kick-off meeting for this project would be. Farnsworth said most likely after the September 2023 GC meeting.
- **Lower Platte River Modeling RFP** – The Selection Panel selected HDR after interviewing three different consultants. Work is underway to develop a detailed scope and budget for this project with the selection consultant.

PRRIP PEER REVIEW

Smith summarized the contract form for PRRIP peer reviewers to be used for the Wet Meadow Hydrology Report Peer Review and the Sediment Augmentation Synthesis Report Peer Review.

FC MOTION: *Brundage moved and Gebhart seconded to approve the 2023 PRRIP Peer Review Contract Form. Motion approved.*

IN-CHANNEL DISKING

Tunnell summarized the 2023 in-channel diking RFQ and associated contract form. Tunnell said we did add the Rowe Sanctuary Reach to this year's diking work under a management agreement with Audubon Nebraska, it has been a while since we have done diking work in this segment and the existing approved budget should cover this work as well. Brundage asked about the potential interaction of this work with evaluation of the germination suppression flow releases. Farnsworth said yes because we are looking at the whole reach, but we will focus diking on areas where vegetation is so established that we



cannot learn much more in terms of germination suppression flows on that vegetation. We will reset those areas and then continue learning in the future with additional germination suppression releases.

FC MOTION: *Gebhart moved and Rabbe seconded to approve the 2023 PRRIP In-Channel Disking RFQ and Contract Form. Motion approved.*
