Welcome and Administrative

Chairman Zorn called the meeting to order at 1:00 pm Central Time and the group proceeded with introductions.

Zorn asked for agenda modifications. None were offered.

Zorn asked for the LAC's recommendation on the minutes of the February 1, 2021 LAC meeting.

Matt Rabbe made a motion to approve the minutes from the February 1, 2021 LAC meeting. Motion seconded by Brock Merrill and passed unanimously.

2020 PRRA Subcommittee Report

Information and discussion (Matt Rabbe, USFWS and Chair of the PRRA Sub-committee,)

Matt reviewed the annual public comments following the 2020 hunting season. No items rose to the need to change anything for 2021. Sub-committee recommended no change for 2021. Matt will present to the GC at the June 2021 meeting and explain the LAC decided to make no recommendation for any changes.

2101 and 2102 Land Reviews

Information and discussion (Tim Tunnell, ED Office,)

Tim Tunnell reviewed the field review of parcel #2101 and 2102 just upstream of 2020001 (Robinson) in the Chapman Bridge Segment. Some discussion over the land and power lines in the area. The lines and potential bird strikes are somewhat protected by the trees along the east side of the lines. The trees provide a natural barrier if they remain present. Ted LaGrange added that wetlands are in good shape. Very little work is needed to maintain a wide channel in this portion of the river. Some cedar control appears to be needed in the future. The review team recommended pursuing both tracts of land.

John Shadle asked that Jim Jenniges comments on the property be recalled for the record.
