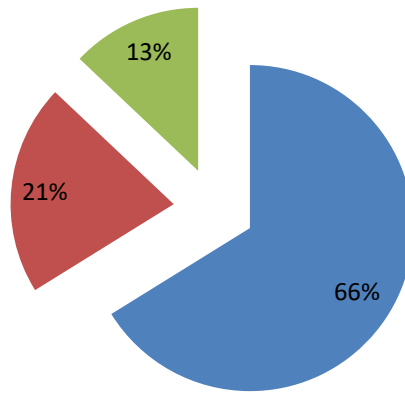

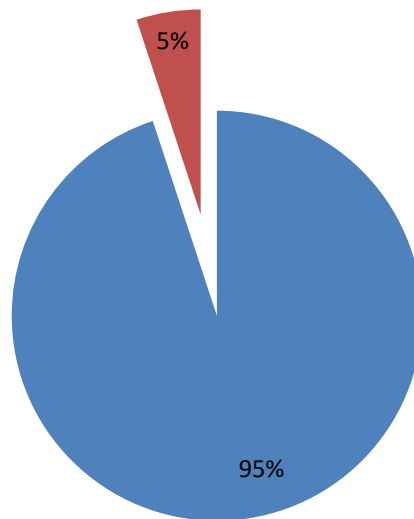
## Ownership by Type
