32	Welcome and Administrative
33	Chairman Scott Woodman called the meeting to order at 9:05 am Central Time and the group
34	proceeded with introductions.

36	Woodman asked for agenda modifications and none were provided.
37	
38	Wingfield made a motion to approve the minutes from the November 18, 2009 LAC
39	meeting. The motion was seconded by Merrill and passed unanimously.
40	
41	GC Meeting Update

- 42 Czaplewski gave an update on GC activities since the LAC last met. The GC met on December
- 43 1 & 2, 2009 in Denver, CO.
- 44



- 45 Czaplewski reported that the GC approved the 2010 budget, budget work plan, and ED Office
- 46 contract. The USFWS provided a briefing to the GC on the Platte River Caddisfly. The GC
- 47 formally turned down Tract 0818, as an acceptable price could not be agreed upon during
- negotiations with the seller. John Lawson was elected GC Chair for 2010, and Jennifer
 Schellpeper was elected Vice Chair.

- 51 The GC also approved moving to a quarterly meeting schedule, with the next meeting scheduled
- 52 for March 9 & 10 in Kearney, NE.

54 Other Committee Coordination Information

- 55 Smith gave a brief update on recent TAC activities. The TAC last met on January 21, 2010.
- 56 They reviewed and spent time discussing the land management plans that will be discussed later
- 57 in this LAC meeting. The TAC also approved the concept of the experimental design approach.
- 58 Specifically, creating experiments to examine concepts fundamental to the Program such as
- 59 habitat selection and habitat creation and maintenance. They provided feedback on the Least
- 60 Tern/Piping Plover Monitoring Protocol, the Least Tern/Piping Plover Research Protocol, and
- 61 the Forage Fish Monitoring Protocol.

- 63 Smith informed the LAC of a Program Adaptive Management Plan Reporting Session, scheduled
- for February 17-18, 2010, in Denver, CO. All interested committee members are invited. The
- 65 two-day workshop will include reports from all staff, Program partners, and contractors working
- 66 for the Program on AMP implementation projects, such as species monitoring, Lower Platte
- 67 stage change study, Sediment augmentation feasibility analysis, and more.

- 69 Farnsworth gave an update on recent WAC activities. The WAC is working on progressing
- 70 Water Action Plan alternatives, including options for groundwater recharge, recharge reservoir
- feasibility, and investigating the economics of water use in the central Platte basin as a basis for
- 72 possible water management incentives.

74 Update on Land Management

- 75 Tunnell gave an update on a number of land management activities under way.
- Grinding and removal of cleared trees and shrubs from the north side of the Wyoming
 property (2008001) is about 90% done. Upon completion, the area is planned to be over
 seeded with commercial native seed mix.
- Estimates to rework the fences at 2008001 have been received, and the work is planned to take place prior to May 1, 2010.
- Tunnell is working with CPNRD to plan a prescribed burn for the entire island area
 between the north and south channels, as well as the area south of the river nearly to the
 high bank.
- The Cottonwood Ranch (2008002) habitat enhancement project is still under way. The clearing and leveling of a large island in the channel is about 90% complete. An area of tree clearing south of the channel is about 50% complete. The burning and burying of tree piles from the proposed off-channel sand & water area is about 75% complete.

- Tunnell is working with NPPD and CPNRD to plan a late spring prescribed burn for
 Lloyd Island and a half section of wheatgrass south of the river on 2008002.
- Quotes have been received to remove trees and clean up ditches, old dilapidated fences
 on properties 2009001 and 2009004. Work is to be awarded in the next week and
 completed by April 1, 2010.
- Bids were solicited from the public for the removal (sale) of the residence and garage
 located on property 2009003. A bid for \$1,500 was accepted, and the residence and
 garage will be removed by the bidder by April 1, 2010.
- The marginal cropland areas on 2009003 are planned to be burned to remove biomass
 and seeded this spring. The perimeters of the crop areas have been disced in preparation
 for fire.
- Cook Construction was the low bidder for IFB 09:08, 2009003 sandpit rehab and tree clearing. Seven bids were received for the work. Work was started on the project on January 21, 2010 and tree removal is already 75% complete. The deadline for completion is April 1, 2010 for tree removal and sand pit rehab and June 1, 2010 for completion of the burning and burial of the tree debris.
 - The abandoned residence on 2009005 was demolished on January 15, 2010. The home contained asbestos, which was removed (and all appropriate paperwork filed) prior to demolition.
 - Tunnell is working with county weed control agencies to schedule noxious weed management for Program properties in the upcoming season.

110 Land Management Plans

Brei introduced the current version of the complex and tract level land management plans. This
is the second time the LAC has seen the documents, and several comments were received and

113 incorporated into the current version. Brei identified a few outstanding philosophical issues that

- 114 were not able to be incorporated into the plans due to conflicting comments received. A memo
- identifying these issues was distributed in advance to the LAC. Brei opened the floor for
- specific comments on the plans and the LAC discussed the plans at length.

Several modifications were made to the plans during discussion. Heaston made a motion to approve all presented Complex, Tract, and Work Plans (Elm Creek Complex Plan and

- Work Plan, incl. 2009002 and 2009005 tract plans; Ft. Kearny Complex Plan and Work
- Plan, incl. 2009002 and 2009005 tract plans; Ft. Kearny Complex Plan and Work Plan, incl. 2009001 and 2009004 tract plans; Tract 2009003 O&M Plan and Work Plan;

2008002 Work Plan) as edited, and forward them to the GC with a recommendation to

- approve. Wingfield seconded and the motion passed unanimously.
