Item 2 – Drill 4-inch x 100-foot livestock well

- Cost includes drilling, 4" 200# PVC Casing, Bentonite, Steel casing, Gravel Pack, Chlorination, and Registration Fee.
- Lump sum unit cost must include all costs of whatever nature necessary for supplying, installing, and ensuring proper function of the drilling of a new livestock well to meet or exceed NE DNR specifications including registration.


